This is a synopsis of the minutes of the meeting of the Indy Region BOD June 14, 2010 at Dooley O'Tooles, 6:30 PM. There were 7 directors and 6 guests present. Minutes of the previous meeting were approved.

**Old Business** Dave read a letter of resignation from Bryan Deane: due to job conditions and time restraints, Bryan is unable to continue filling the office of RE. As Assistant RE, Dave Dusterberg moves to position of RE.

**Treasurers Report** Rich emailed the report to everyone before the meeting. After minor discussion, the report was approved.

**Clutch Chatter** Pauletta requested as much material as anyone can get to her. Deadline for next issue is the 15<sup>th</sup>.

**Website** John continues to do a great job for us, and updates / improves the website frequently.

**Membership** Pauletta reported current membership is 457.

**Activities** Next Club Nite Out will be July 6<sup>th</sup> at O'Tooles. Permanent schedule is published in CC and on the website.

**Rally** Wendy Harrison reported to the BOD for Chuck. The June 27 rally has received the sanction, and will be a multi-type Rally. Ted Drummond is setting up the July 31 Rally to be a Tour / GTA Rally, and is nearly ready for prechecks. Susan and Wendy will be preparing the Aug 21 Rally as a GTRA only, and are hoping to partner with the Big Brothers / Big Sisters.

**Race** We notified GLDiv and other people of our cancellation of the August Nationals. We continue to hope for October, and continue to research other possibilities.

**Solo** We had 121 entrants for the Grissom points event 3, with good feedback from competitors. Bob Miller and Scott have checked into getting DaBus roof and sides sealed, expect to go ahead soon.

National Tour Solo for Grissom on July 3 & 4 preparations are ready, and volunteers are selected for the various specialty chiefs. Other volunteers to help with the event will be welcomed. Scott is ordering 40 more cones to have fresh for the National Tour.

**Rallycross Program** Matt Jordan reported; he has a basic program in place, but needs some way to find a site.

**New Business** With Bryan resigning, we have opening for asst RE and another at large member. Andy Welden has agreed to take the Asst RE position. Geoff Chambers missed by one vote at the election of at large members, and was asked if he would serve. Geoff agreed, and the acceptance was unanimous. Thank You Geoff and Andy for stepping in to help!

Some members mentioned a preference to move our BOD meetings from Mondays back to Thursdays. The second Thursday is available for Dooley O'Tooles, and the board voted to move meeting dates to the second Thursday of each month.

Next BOD meeting scheduled for Thursday, July 8<sup>th</sup> at O'Tooles.  
Meeting was adjourned.

I apologize for the problems with the schedule. I thought that we had found a solution to the September date, only to have it fall through right after the last issue of Clutch Chatter went to press. At this time there is an invitation out for the date, but no indication of interest. So we can hope that we have an event, but we may not.

The flyer for the July 31 event is posted on the web site. It will be a “universal” event; i.e. you can choose to run it as a Course rally (timed), Tour rally (timed), or GTA (untimed). General Instructions for the event will be posted to the web site by July 15 so that you have time to study them before the event. Pre-registration will be accepted by snail mail or email.

Four of our regular teams made the ten hour trek to northern Wisconsin for the Chippewa Trail National rally and Chippewa Blues Regional rally. I am bragging a bit because we comprised fully a third of the National field. Way to show that we have a vital program going down here! Last month I spoke of the pleasures of scenery and just how brisk a rally can be. The Chippewa’s scored on both counts! The Blues rally featured a “plot and bash” format; i.e. at the beginning of each leg you had to plot the route on a map using the instructions given, and then go like heck to complete the course in the allotted time. I will say that the speeds were very brisk, as in 55 on gravel! (We weren’t told to run that fast, it’s just what had to happen to make the specified finish time after I took too long to figure out which was the preferred route.)

J4-2010 was both simpler and harder than some of our recent events (you ask how it can be both?). It was simpler from the standpoint that there were only two main road determinants instead of the usual three, and because two of the legs were pure tour; i.e. no traps at all. It was harder because some of the speeds were a bit brisker, and because I really challenged the competitors to understand the two MRD’s that I did use. [Note: this is being written 10 days before the event runs.]

These are some of the benefits above and beyond competing for the Competitor of the Year Award. Come out and give Rally a try. You may be surprised about how much fun it is.
